- **Please can you tell me how many fatal accidents there have been on the A40 junction at Raglan and Dingestow from 15/11/2022 to today.**

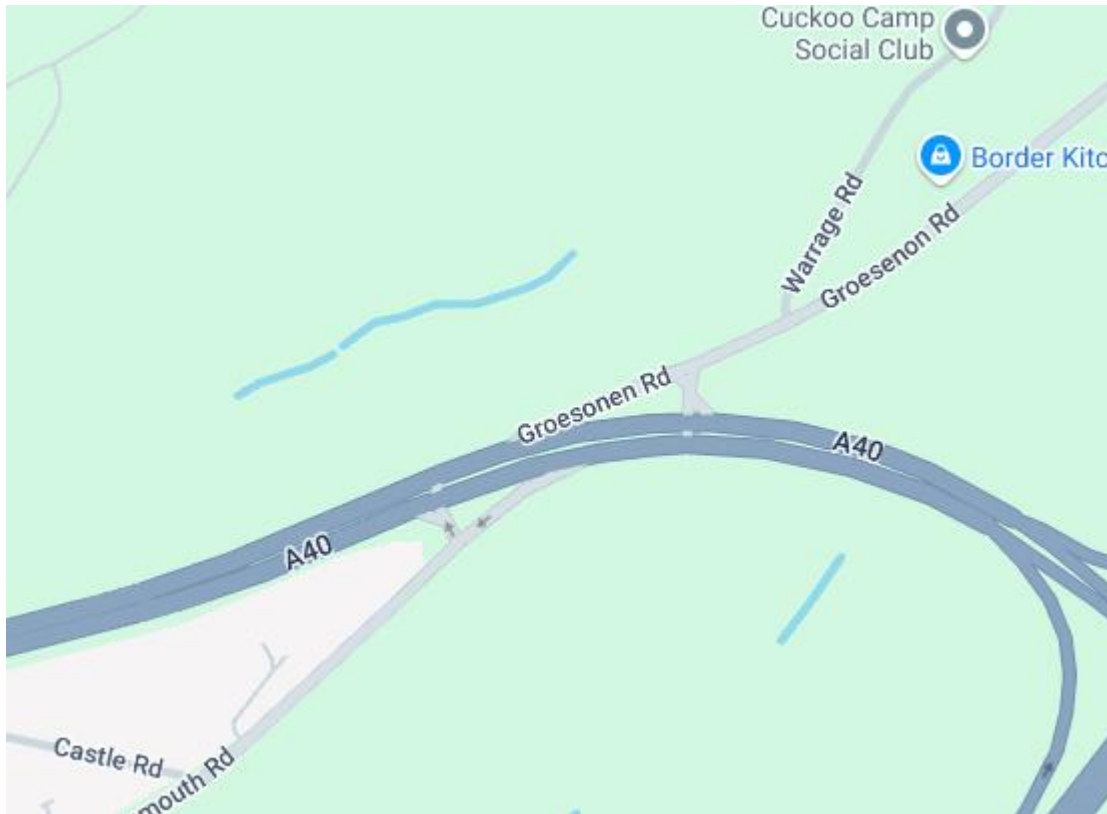
### **CLARIFICATION NEEDED FROM REQUESTOR 21/03/25**
